Frequently Asked Questions

How many homes are in the community?

There are 45 townhome-style condominium lofts to be built within the community. We have 2- and 3-bedroom plans to choose from and all include 2 or 2.5 bathrooms.

Is there a Homeowners Association (HOA) and what are dues?

Yes, the Paragon Lofts Home Owners Association dues are \$285 per month. HOA dues include water usage, common area & building landscape maintenance, HOA management, building insurance policy, pest control, and capital reserves for exterior painting, roof maintenance/repairs, etc. See the HOA budget for details.

How many parking spaces are included with each home?

Each home has its own private two car garage, which are either tandem or side-by-side per plan, and a driveway.

Will the homes have a warranty?

Yes, Paragon Life Builders provides a warranty for workmanship and materials during the 1st year of ownership, and a warranty for systems (electrical, plumbing, HVAC) during the 1st and 2nd years of ownership. Additionally, Paragon Life Builders purchases a structural warranty through Professional Warranty Service Corporation (PWSC) at the close of escrow on behalf of the homeowner, which provide for structural coverage of qualified defects for years 3 through 10 of ownership.

Do you offer a Broker co-op program?

Yes, we currently offer a Broker co-op fee. Please note that all clients must be registered upon the prospective Buyer's first visit to participate. Broker co-op fees are 3% of the base sales price.

Do I need a real estate agent to purchase a home at Paragon Lofts?

No, it is not a requirement to have a real estate agent to purchase a new home at Paragon Parkside. The good news is that our sales counselor is here to help you every step of the way throughout the home buying experience. We understand buying a new home is a significant purchase so our team is here to help address your questions along the way, and even after you move-in.

Which schools will children attend?

The elementary school is Louis Weiner Jr., the middle school is Jack Lund Schofield Junior High, and the high school is Silverado. Please call the Clark County School District to verify information as boundaries and availability are subject to change without notice.

What is the deposit required to purchase a home at Paragon Lofts?

A \$5,000 earnest money deposit is required and payable to First American Title Company.

Do I need to be pre-approved with Paragon Life's preferred lender?

Yes, all prospective buyers must be pre-approved with Citywide Mortgage or have provided proof of funds for cash purchases. There are incentives available from the builder and the lender if a buyer closes the loan with Citywide Mortgage. Ask your sales counselor for more details.

What kind of interior upgrades and/or options do I get to select for my new home?

When it comes to personalizing your new home, it will depend on the construction stage of the particular home(s) you are interested in. Options include cabinets, countertops, flooring, appliances and more. Please ask your sales counselor for more details.

Is there shopping, dining and resources nearby?

Within 1.5-miles, residents have access to grocery, shopping, outlet stores, and South Pointe Casino. Within 2.8 miles is Town Square for upscale dining shopping and entertainment. The Las Vegas Strip and McCarran Airport are approximately four miles away.
